Wellington Management Group LLP ("Wellington Management"), a limited liability partnership validly existing under the laws of the Commonwealth of Massachusetts, USA, headquartered at 280 Congress Street, Boston, Massachusetts, 02210, USA, in its capacity as the ultimate parent company to a series of companies that exercise investment management activities with clients outside of Brazil (the "Wellington Entities") and on their behalf, in compliance with Article 12 of the CVM Instruction No. 358, dated January 3, 2002, as amended ("CVM Instruction 358"), hereby informs that the portfolios of clients under the Wellington Entities' management (the "Accounts") have disposed, through certain transactions on stock exchanges, certain preferred shares issued by Banco ABC Brasil S.A. ("Company"), thus holding currently 5,257,813 preferred shares, representing 4.83% of all preferred shares issued by the Company (on the basis of a total number of shares 108,862,625).

Wellington Management also informs that the Wellington Entities have proxy voting rights on behalf of certain Accounts, in connection with the discretionary management powers.

This is a minority investment that does not involve a change in the composition of corporate control or a change in the management structure of the Company. Currently, the Wellington Entities do not intend to purchase for the Accounts any additional shares of the Company with the intent to acquire control or to change the management structure of the Company.


