Considerando a abstenção manifestada pelos acionistas representados pelo Sr. Daniel Alves Ferreira e que não houve objeção por parte dos demais acionistas presentes, será convocada nova Assembleia Geral Extraordinária a se realizar, em nova convocação, no dia 22 de abril de 2014, às 11h, na sede social da Companhia. Foi autorizada a lavratura da presente ata na forma de sumário e a sua publicação com omissão das assinaturas dos acionistas, conforme faculta o art. 130, §§ 1º e 2º, da Lei nº 6.404/76.
